Revised HAR-3 Health Assessment Record (Blue Form)

State law requires complete primary immunizations and a health assessment by a legally qualified practitioner of medicine, an advanced practice registered nurse or registered nurse, a physician assistant or the school medical advisor prior to school entrance in Connecticut (Connecticut General Statutes [C.G.S.] Sections 10-204a and 10-206). An immunization update and additional health assessments are required in Grade 6 or 7 and in Grade 9 or 10. C.G.S. Section 10-206 (d) further requires that the results of each health assessment be recorded on forms supplied by the State Board of Education (SBE). The HAR-3 Health Assessment Record is the tool utilized by the SBE for such purposes and has been revised as of April 2010. In addition to being utilized as the Health Assessment Form for students' physicals, the revised form may now be used for health assessments required every year for students participating on sports teams. This 3-page document is organized as follows:

- page one - Part I To be completed by parent/guardian;
- page two - Part II Medical Evaluation; and
- page three - Immunization Record.

Reinstatement of Prekindergarten and Kindergarten School Immunization Entry Requirement for Haemophilus Influenzae Type B (Hib) Vaccine

Hib Vaccine Supply

The Centers for Disease Control and Prevention (CDC), in consultation with the Advisory Committee on Immunization Practices, the American Academy of Family Practitioners, and the American Academy of Pediatrics, is recommending reinstatement of the booster dose of Haemophilus Influenzae Type B (Hib) vaccine for children aged 12–15 months who have completed the primary series. Hib vaccine supply is now sufficient to institute active recall of patients in need of a booster dose of Hib vaccine. Health care providers were notified in March 2010 that they could resume administering the Hib booster dose to all children who had their booster dose deferred during the vaccine shortage.

Reinstatement of Hib Booster Dose

The Hib booster dose is now once again required for school entry. Effective September 1, 2010, schools will resume enforcement of the Hib requirement of at least one dose of Hib-containing vaccine given on or after the first birthday for all children under 5 years of age. A one month catch up period is permissible for those children whose immunizations were deferred due to the shortage. Children who might have had their Hib booster dose deferred because of the vaccine shortage would likely have been born during the timeframe of September 2006 through July 2008.

Connecticut State Department of Education Circular Letter: C-12

Summary of the February 1, 2010, Report Recommendations to the Legislature on the Status of Analysis of Bullying Policies in Connecticut, release of National School Climate Standards and the General Trends of Bullying complaints coming to the Connecticut State Department of Education (CSDE)

On July 1, 2008, the Governor signed amendments to the existing Connecticut policy on bullying in schools (originally passed on July 1, 2002, and amendments made in 2006). Among the changes in 2008 was for the CSDE, within available appropriations, to report to the Legislature no later than February 1, 2010, on the following:

- review and analyze the policies submitted to the CSDE pursuant to Connecticut General Statutes Section 10- 222d;
- examine the relationship between bullying, school climate and student outcomes;
- document school districts' articulated needs for technical assistance and training related to safe learning and bullying;
- collect information on the prevention and intervention strategies used by schools to reduce the incidence of bullying, improve school climate and improve reporting outcomes;
- develop model policies for Grades K-12, inclusive, for prevention of bullying; and
- make any recommendations regarding additional activities or funding to prevent bullying in schools and improve school climate.
